As a reminder, I will not be at the GFSI board meeting on Tuesday as I will be attending a Tamarack workshop on Collaborative Leadership with Liz Weaver.

I did have a couple of updates though that will be of interest to the board.

I continue to work with the provincial groups on development of an Atlantic symposium on **Basic Income** aimed at elected representatives from all levels of government. The purpose is to rally support for the upcoming release of a report backed by all provincial parties in PEI requesting that the federal government implement a BI trial there. (Interesting to note that according to Herb Emery, they are recommending that the control case for a pilot be the Moncton region.)

Attached below is the working doc for an invitation. The hybrid event will cover:  
5 things BI is and 5 things it isn't ( myth busting)  
The economic case for BI ( purse strings)  
How BI lends itself to improving the quality of life for citizens (heart strings)  
Call for Action: how to keep informed on developments and the request to rally behind PEI

Also, I had a call with **Suzanne Johnstone, Trustee of the Health Authority**, in which I presented the case for the province to invest in programs offering folks on low income with chronic health conditions access to healthy food as a preventative medical intervention. In preparation for this chat, I did up a report on similar projects happening across Canada and noted that much is happening in this regard in the US and UK.

Close to home, NS has a program in which people with diabetes and other chronic conditions are given coupons by health care professionals and social workers that can be redeemed at farmers markets. The aim is to improve their health, reduce the need for treatment and to support local farmers. She responded supportively, and offered to share the report with her counterpart, Gerald Richard and with the DM of Social Development. Given what is on her plate, I was indeed impressed that she followed up on her offer to discuss this idea with me and that gave me 20 minutes of her time. Now to see where it goes.

Last update: Fredericton Region Solid Waste posted the position for a Social Inclusion Coordinator to which I have applied.
